- left thumb impression (on white paper with black or blue ink) (size: 20-50 KB)
- a hand written declaration (on a white paper with black ink) (size: 50-100 KB) (text given below)

- Signature in CAPITAL LETTERS will NOT be accepted.

- Keep the necessary details/documents ready to make Online Payment of the requisite application fee/ intimation charges
- Have a valid personal email ID and mobile no., which should be kept active till the completion of this Recruitment Process. Bank may send intimation to download call letters for the Examination etc. through the registered e-mail ID. - The signature, left thumb impression and the hand written declaration should be of the applicant and not by any other person.
- If the Applicant's signature on the attendance sheet or Call letter, signed at the time of the examination, does not match the signature uploaded, the applicant will be disqualified.
- Signature / Hand written declaration in CAPITAL LETTERS shall NOT be accepted.

Scanning the documents:

Note:

body. Candidates will not have any claim for a re-test. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.

- 2. Decision of TMB in all matters relating to recruitment will be final and binding on the candidate. No correspondence or personal enquiries shall be entertained by the TMB in this behalf.
- 3. If the examination is held in more than one session, the scores across various sessions will be equated to adjust for slight differences in difficulty level of different test batteries used across sessions. More than one session is required if the nodes capacity is less or some technical disruption takes place at any center or for any candidate.
- 4. TMB would be analyzing the responses (answers) of individual candidates with those of other candidates to detect patterns of similarity of right and wrong answers. If in the analytical procedure adopted by TMB in this regard, it is inferred/ concluded that the responses have been shared and scores obtained are not genuine/ valid, TMB reserves right to cancel the candidature of the concerned candidates and the result of such candidates (disqualified) will be withheld.
- 5. - (iii) Testwise scores and scores on total is reported with decimal point upto two digits.
